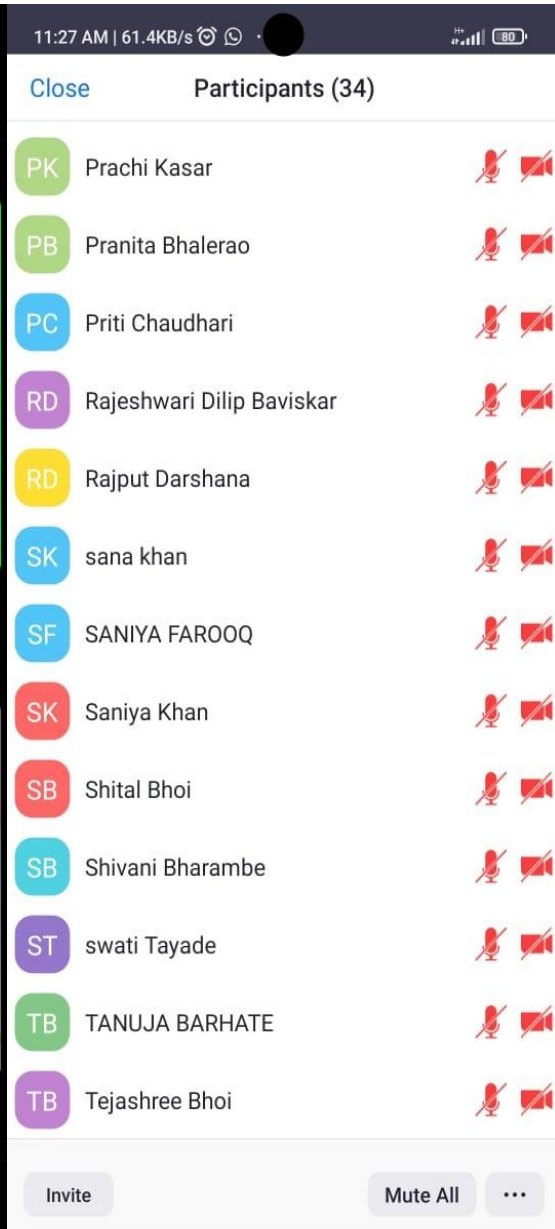
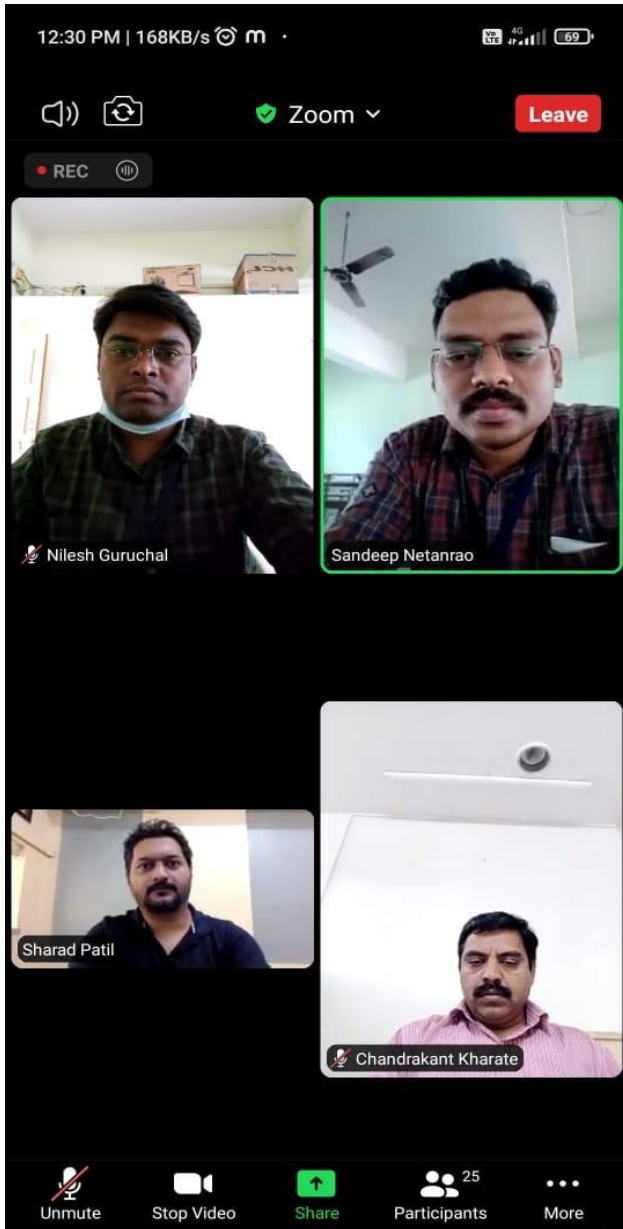

- Six students were registered under the activity Carieer Katt- IAS Aapalya Bhetila and continued the online training under the same activity.



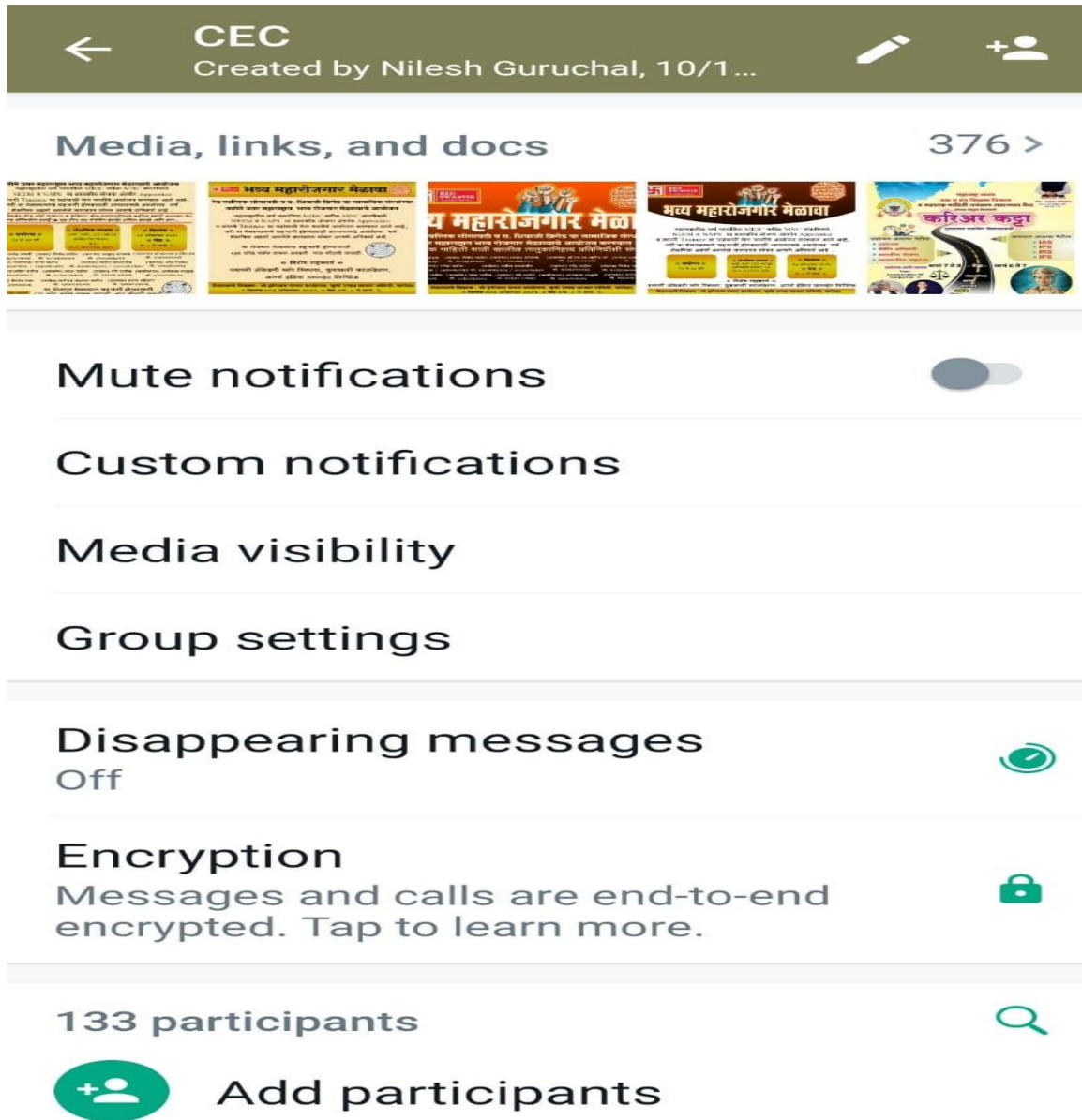
