1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Smt. P. K. Kotecha Mahila Mahavidyalaya, Bhusawal run by Shri Saraswati Vidya Prasarak Mandal, Bhusawal is established in 1984. It is a premier women's college in the Bhusawal Tahasil. Bhusawal is a place in North Maharashtra knows for second most big Railway Junction in India. This city is located on the bank of pious Tapi River which is also known as 'Suryakanya' in Khandesh region.

The college is affiliated to KavayitriBahinabai Chaudhari North Maharashtra University, Jalgaon (M.S.) and is reaccredited with B+ Grade (CGPA 2.53) in the 3rd Cycle. The college offers 12 UG Programmes and 05 PG programmes in the faculties of Arts, Commerce & Management and Science. The college also provides additional input to the students by way of wide array of add on certificate/value added courses like Communicative English, Women Entrepreneurship, Human Rights, Basic Beauty Parlor, Dress Making ,Core Python Programming, GST, Nursery and Industrial Chemistry.

At present 9 full time teachers are having Ph.D. and 03 with M.Phil as highest qualification. It has good infrastructural facilities and support services. College has zero energy building since 2019-20.

Extension activities are organized through NSS, Yuvati Sabha, Student Welfare Committee etc. Activities such as self defense training, medical checkup, blood donation camp, Swaccha Bharat Abhiyan, distribution of masks, grains and cloths to the needy people during COVID-19 pandemic , visit to tribal area and tribal schools, organization of street play on social issues, road safety campaign etc. are organized in collaboration with GOs and NGOs. These activities create awareness about social issues among students.

The library holdings fulfill the academic resource for students and faculty members. An e-library facility through INFLIBNET N-List is provided. The library has cloud base LIBMAN Master Soft software. Book Review Competition is conducted every year by Library. The College has provided online admission facility to students.

Alumni, being the educational ambassador of the college are kept in touch with the institution through alumni meet. The institution invites the alumni members to come and deliver lectures. They also participate in annual gathering and sports tournaments occasionally.

- Lack of International Linkages & collaboration for teaching-learning-research etc. due to rural hinterland.
- Non availability of local employment opportunities.

- Location in agricultural and socio-economically backward area challenges to students for vibrant mobility in terms of placement, skill enhancement and Self-entrepreneurships.
- To maintain a balance between traditional courses and need of professional skills.
- To maintain infrastructure and best teaching faculty with less financial support from the government.
- To bring back the regular attendance of the students after pandemic of Covid-19.
- To increase the financial contribution by alumni for institute development.

1.3 CRITERIA WISE SUMMARY

Curricular Aspects

The College, being affiliated to Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon follows the University curriculum and offers UG and PG programmes in Arts, Commerce & Management and Science. The curriculum is designed by the University. Faculty members are keen to participate in curriculum designing workshops arranged by the University. Our faculty members also work as members of Board of Study. The institution ensures effective curriculum delivery through its action plan. Effective curriculum delivery is ensured through the well-planned mechanism and documented processes to accomplish vision and mission of the institute. It is ensured through the Academic Calendar, College Time Table and Teaching Plans for smooth functioning of regular lectures, Internal Test and Tutorials, throughout the semesters for continuous internal assessment of the students. At the end of each semester teachers submit syllabus completion progress report.

The college offers 12 UG Programmes and 05 PG programmes in the stream of Arts, Commerce and Science. Elective options are offered at UG and PG level. All the programmes offered by the college have semester /CBCS system. Institution offers add on/certificate courses which provide ample academic flexibility to students. University has taken care of cross cutting issues like Gender, Environment and Sustainability, Human Values and Professional Ethics while framing syllabus. College has also taken care of the implementation of cross cutting issues to reflect vision and mission of the institute. A gender issues are focused and addressed through various activities by the Yuvati Sabha, Student Development department and N.S.S. Unit of the college and also promotes environmental protection through various activities like tree plantation and other sustainable development programs.

The projects are undertaken by first year students in Environmental Studies and the students of T.Y.B.A., B.Com. B.Sc., BCA and M.Sc. students. For the effectiveness of curriculum aspects and ambience of the institution the IQAC obtains online and offline feedback from various stakeholders, such as Students, Teachers, Employers, Alumni, etc. Collected feedback is analyzed and necessary suggestions are put-forth by the faculty and communicate informally to member of BOS.

Teaching-learning and Evaluation

Absolute transparency and systematic mechanisms are adopted in the admission process. The admissions to all programmes are finalized as per reservation norms of the University and the Government of Maharashtra. The admission to PG programmes such as M.Sc. Computer Science and Organic Chemistry are given through the Central Admission Process.

Around 70 - 80% of the students come from weaker sections of society such as SC/ST/OBC/EBC and from semi urban and rural area. The college adopts students –centric methods such as experiential learning, participative learning, and problem solving methodologies to enhance learning experiences. Teachers use various ICT enabled tools for effective teaching and learning.

UGC norms are followed for the appointment of competent teachers in sanctioned and approved vacancies. College recruits permanent faculty, CHB and also as Management Appointee. The teacher as a mentor offers guidance that helps the learners to pursue their education and develop their interpersonal relationship.

The college adheres to the norms prescribed by the affiliating university and hence, follows the evaluation structure as framed by the university. Bar coding, continuous assessment, providing of photo copies of assessed answer books etc. improve the transparency and reliability in examination system. College Assessment results are communicated to the students with due Grievance Redressal system. Every year the proper mechanism is followed to obtain Student Satisfaction Survey.

Good academic record, value added courses, co-curricular and extracurricular activities help to improve the students' role and their involvement in building better society and stronger nation. Around 30-40% students pursue their higher studies.

Research, Innovations and Extension

Research Promotion Committee (RPC) and Research Advisory Committee (RAC) are formed to monitor research activities in the college. Teachers as well as students are encouraged to undertake research activities like research papers, research projects etc. by providing conducive environment. Two teachers have sanctioned MRP under VCRMS scheme by Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon. The faculty members have published 72 research papers in UGC care listed, Scopus, Web of Science; Peer Reviewed indexed referred journals. Teachers had published 20 books, chapters in edited books and in conference proceedings. 07 faculty members are approved as Ph.D. guides by the University. At present 08 students are pursuing Ph.D. under their guidance and 07 students have been awarded Ph.D. degree by the University. The college organized 30 conferences, seminars, workshops and 03 training programs. Most of faculty members participated in conferences, seminars and workshops to share their knowledge and views.

The College plans programmes and extension activities through NSS, NCC, Yuvati Sabha and other committees. The extension activities based on Environmental Issues, Health Awareness, Swachha Bharat Abhiyan, Gender Sensitization etc. are organized in collaboration with GOs and NGOs create awareness among the students about social issues. This helps to improve communication skill, team work among the students for being socially sensitive human being. The college has two MoUs with other organizations to implement activities for the benefit of the students.

Infrastructure and Learning Resources

The College is located on a spacious campus that spans 2.5 acres of land, with a total built-up area of 4628.56 sq. mts. and beautiful academic surroundings. The college has spacious 23 ventilated classrooms and 13 laboratories. There is a hostel which provides all the necessary facilities with an accommodating capacity of 80 students. All other support facilities such as Smart Classroom, Seminar hall, Cultural hall, Stage for Cultural events, play ground, gymkhana, gymnasium, canteen, vehicle parking, , tiffin park etc. are available for curricular, co-curricular, extracurricular and administrative activities.

There is an administrative building which comprises Principal's and Vice Principal's Cabin, IQAC office and Administrative Office. ThreeRO systems, well-equipped infrastructure for Staff Room, NSS, Health Center, Beauty Parlor Room, Dress Making Room, Canteen, Girl's Common Room are available in the campus. The institution has a Vermicompost unit and a Botanical Garden. There is ramp facility for the differently-abled students.

The college library is well-equipped and automated with Master Soft's LIBMAN- Library Management System. Library has a collection of 16729 Books,8 Journals,9 Magazines, 2345 bound volumes of periodicals & journals, 04 Newspapers, Question Bank and N-LIST subscription.

The institution has 86 computers. The college uses Master Soft Software ERP for admissions. The institution has solar power grid system of 20KVA.A BSNL Optic fiber broadband plan with enough bandwidth of 100 Mbps is made available to satisfy the institution requirements. With regard to all service providers the College has its own maintenance policy & also took the help of hired agencies as and when required.

Student Support and Progression

The institute provides number of mechanisms for students support and mentoring. Admitted students are taken care of by providing various support facilities in the form of indoor and outdoor sports facilities and encouraged for participation in co-curricular and extracurricular activities.

The students from weaker sections of the society avail central and state government scholarships (GOI) and free-ships. EBC/EWS, Rajashri Shahu Maharaj Scholarship are also available. Students are also facilitated by support services like Earn while Learn Scheme, student group insurance, financial support for economically poor students. Scholarships for physically challenged students, post matriculate scholarship for minority community etc. are also made available.

For overall development of students college conducts various skill oriented Add-on/Value added courses for achievement of soft skills, life skills, language and communication skills development. College also caters students by providing ICT oriented certificate courses to make the students aware with trends in technology for pursuing their professional goals.

Students' grievances and concerns are also addressed through the Grievance Redressal Committee, Anti ragging and Internal Complaints Committee.

Efforts are taken for career counseling and placement in various fields. Students' Council is formed as per the University norms.

More than 75 % of total students complete their programmes in stipulated period. Around 38 % students pursue higher studies.

Various activities are organized under the leadership of nominated students' representatives. The students participate in games, seminars, cultural, curricular, co-curricular, extra-curricular and extension activities and competitions in and out of the college, has brought laurels to the individuals and the institution.

College has registered Alumni. There are 07 number of executive committee members, life members 89 and 142 annual members (for academic year 2022-23). Alumni Association conducts various activities for the guidance to new students, progression of alumni students and for society.

Governance, Leadership and Management

The college is affiliated to KBC North Maharashtra University, Jalgaon (M.S.). It functions according to the directives of UGC, Govt. of Maharashtra, IQAC, CDC and academic committees. Nominations and designations are offered to each of the representative as per the norms. All the continuants in their capacity contribute in sustaining and enhancing quality in higher education in the institute.

The institutional governance and leadership are in accordance with the Vision and Mission. The institute offers effective governance and leadership through its practices. Management, the Principal, Vice-Principal, HODs and the faculty jointly work on policies and plan. Student representatives are also given leadership in the decision making bodies. The perspective plan is designed in line with the vision. It helps as a roadmap for the growth and development of the institution. Appointments are carried out according to the norms of KBC North Maharashtra University, Jalgaon, Govt. of Maharashtra and UGC. The institution has Performance Appraisal System for teaching and non-teaching staff. Faculty is regularly motivated to undertake the activities for career advancement. The institution has variety of welfare schemes for students, teaching and non-teaching staff. Faculties are encouraged to participate in refresher courses, orientation programmes, short term courses, workshops, seminars etc. for their professional development.

The institute receive grant from Govt. of Maharashtra, UGC,KBC NMU and some other non govt. funding agencies. The other regular sources of income are from student fees of addon, self finance and grantable courses. The institute has well defined procedures for allocation of fund to various segments. It conducts internal and external audits periodically. Transparency is strictly maintained in both internal and external audits.

The institute has an active IQAC. It plays an important role in the planning and implementation of various academic and administrative activities. It is keen to prepare and submit Annual Quality Assurance Report to NAAC office Bangalore. It has put its sincere effort to seek accreditation and reaccreditation of the institute in 2004, 2013, 2019 and is preparing to face 4th cycle of re-accreditation in the year 2024.

Institutional Values and Best Practices

Various initiatives are taken by the institution for the promotion of gender equity such as sensitization campaigns, training, workshops, programs etc. A safe and secured environment is provided to all by providing CCTV surveillance, secured compound wall, common rooms and grievance committees for various issues. Water conservation facilities are also available in the institution. Use of renewable energy, water harvesting,

Vermicompost plants, plantation and waste management are undertaken. Use of Solar energy in solar panels, solar heater, LED lamps and other eco-friendly products with star rating minimized the power consumption.

Quality audits on environment and energy are done from time to time. The college campus is green with various floras. Efforts are taken to keep the campus green and clean by carrying out environmental promotion activities. The institution has a barrier free environment by providing ramps, common room. Institution promoted an attitude of tolerance and inclusiveness towards linguistic, cultural, communal and socioeconomic diversities. Every student is equally treated and the environment of tolerance and belief is maintained.

There is NSS unit conduct awareness rally, cultural programs, and celebration of birth and death anniversaries of visionary leaders. Value based programs are conducted to sensitize students and employees to the constitutional obligations. A Code of Conduct is prescribed for all. Various National and International days and events are celebrated in the institute with great enthusiasm in various ways. Teachers, students, non-teaching staff and even management have their genuine interest in social issues. Two Best Practices identified by the institute are:

1. Inculcation of Ethical Values among students

Institution actively organizes various programs through which Ethical Values are Inculcate among students. Our students' are also participated in various social programs like *Pulse Polio Abhiyan, Road Safety Abhiyan, Swacchha Bharat Abhiyan,* Commodity Bank etc. impart ethical and spiritual values among them.

2. Book Review Competition by Library.

It inculcates reading habit, thinking and decision making among students. It also creates social awareness among the students to improve life skills.

The Institution ensures effective curriculum planning and delivery through a well-planned and documented process including Academic calendar and conduct of continuous internal Assessment

Response:

The institute being affiliated to Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon follows curricula given by the University. The institution ensures effective curriculum delivery through action plan for effective implementation of the curriculum. Institution monitors the implementation of action plan and curriculum by conducting faculty meetings. Academic Calendar is prepared in the beginning of every academic year. Consolidated time table of the college is prepared. Heads of the Departments conduct departmental meetings and work load is allotted to the faculty. The faculty prepare Semester wise teaching plan and follow teaching schedule as per the time table. Students' attendance is cognized by every subject teacher and students motivated to attend classes. Day to day teaching-learning activities is registered in teachers' diary. Teachers organize classroom seminars, symposia, and group discussions. All the teachers use varied teaching methodology to make learning process more effective. The subject teachers arrange regular study tours, field visits, surveys, practical sessions for enhancing their fundamental concepts and knowledge of the respective subjects. Teachers use power point presentations, animations, video clips, etc for effective teaching-learning. Progress reports about completion of curriculum are submitted through Head of the departments at the end of every semester. Institution motivates teachers to participate in curriculum design workshops, faculty development programs, refresher and orientation courses, seminars, conferences, webinars, etc. Well-equipped laboratories are available in college. Fortnightly Posters are displayed by students. Students Workshops are conducted on functioning of Parliament, Election Process, Workshop on Acting etc. Lectures of experts are organized by departments. "Short films show" are arranged on various topics. The IQAC monitors the feedback of the students regarding curriculum delivery which helps in incorporating remedial measures.

The college adheres to the academic calendar for effectiveness of the process of teaching learning and evaluation. Meetings of staff members are conducted at the beginning of every semester and as and when necessary, by the principal. Staff meetings are held regularly to discuss planning, organization and implementation of activities. The Principal assigns responsibility of preparing time table to Head of the departments. The faculty prepares a teaching plan for effective implementation of syllabi at the beginning of every semester. The internal assessment on the basis of required number of tests is conducted by the college as per the directions of the University. Continuous Internal Evaluation is being monitored by an Examination Committee of the college for the smooth conduction, evaluation, and grievance redressal related matters. The internal examination schedule is published well in advance and students are informed about the same through notices circulated in the classrooms, WhatsApp groups. During COVID-19 pandemic all lectures, internal examinations and academic activities were conducted through online mode. The students are well acquainted with evaluation methods, marking scheme and weightage, and the format of question papers during the outset of the academic year. Faculty draws

question papers keeping in view the POs and COs. After the assessment of answer scripts, the marks are conveyed to the students.

The institution adopts following student centric learning strategies to make teaching and learning more effective.

Experiential Learning:

- 1. **Project Work:** Some departments assign Project work to the final year UG and PG students to provide experience of understanding the processes of scientific and literary research within their particular discipline.
- 2. **Industrial and Field Visits:** College organizes visits to industries, banks, business firms etc. in which students get benefitted by experiencing the functioning of such organizations.

2. Celebrations of National/ International Days: The students deliver speeches and expresses their views and ideas on various events such asChhtrapati Shivaji Maharaj Jayanti, Dr. Abdul Kalam Jayanti, Women's Day, Rangnathan Jayanti, Independence Day, Republic Day etc.

3. Co-Curricular Activities: Various competitions like essay writing, poetry recitation, quiz competition, Commerce Talent search Test etc. are organized by the Languages and Science departments in which students participate actively.

5. 2.5 Evaluation Process and Reforms

2.5.1

Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

- Internal/external examination schedule is communicated to students at the beginning of each academic year through academic calendar. Time table of the internal test is prepared by examination committee of the college and display on the college notice board, web site and Whatsapp groups.
- The internal/external assessment process is communicated to the students by the respective faculty in the introductory lectures.
- Syllabus for the internal assessment is communicated to the students well in advance.
- The examination pattern (CBCS) of university is 60+40. 60 marks for university assessment and 40 marks for College Assessments.
- Continuous internal evaluation of the students is adopted by institution that includes written tests and internal oral exam. For the students of Science and Commerce faculty, Journal keeping of the practical sessions is also considered for continuous assessment.
- Examination Committee strictly follows the transparency in the internal/external evaluation.
- As per the guidelines of KBC North Maharashtra University, Jalgaon College conducted online

internal examination by creating Google quiz forms during pandemic situation of COVID-19.

- Internal examination results are communicated to students through notice board.
- It is a practice of the college to show internal examination answer books after evaluation to the students in the class for self-evaluation.
- In case of queries regarding marks, students contact to respective subject teachers or mentors.
- If the student is not satisfied the matter is placed before the Head of department. Then Head of Department and Examination Committee of the college steps in to find the best possible solution.
- The grievances of the students related to examinations such as hall ticket correction, subject change and name correction are addressed at College and University levels depending upon the nature of the grievances.
- Students remaining absent for practical/oral examination on some other grounds (Medical, N.S.S., Sports, Participation in university competitions) are given an opportunity to take up the exam as per KBC NMU Jalgaon rules and regulations.
- Internal marks are submitted through examination committee to the University in stipulated period.
- Change in examination schedule if any, is communicated to students at the earliest.
- Meeting is organized in college for teachers, senior supervisors, squad, nonteaching staff, etc., for invigilation duties to avoid incorrect entries of seat numbers by students, usage of unfair means, and other exam-related issues.
- The university has the provision of supplying photocopies of assessed answer sheets for satisfying the students' doubts in assessment and can apply for the same within fifteen days of declaration of results.
- University provides a photocopy of the assessed answer sheets to student's on-demand within a period of 30 days from the date of receipt of application. After receipt of the online photocopy of the answer sheet, the student consults the respective subject teacher and takes his/ her opinion and in the event of a discrepancy detected and can approach the University for Revaluation within fifteen days.
- The evaluated result is declared in 45 days by the University.

Response:

POs and COs are evaluated through both academic and nonacademic performances of students. The college always emphasizes on the outcome. IQAC regularly directs to execute POs and COs properly.

Parameters like awareness of current issues, basic conceptual clarity, life skills, practical exposure and their overall development of personality are considered to recognize or evaluate.

- The method of measuring attainment of POs and COs of students include tests, seminar, objective questions, home assignments, viva-voce and projects.
- The progress of the students is continuously monitored by the subject teachers through the practical sessions which will also help to know the level of COs attainment.
- Students are motivated to involve in curricular, co-curricular and extracurricular activities through their departments, NSS and different committees. Some students opt for competitive exams held by Government, PSU and private organizations.
- College organizes various programs such as exhibitions, book review, quiz competitions, freshers' day, send-off function, teachers' day, *Shardotsav* (cultural activity), annual gathering, sports meet etc.
- Students are also encouraged to take part in workshops, seminars, conferences, *Avishkar* etc. organized by other institutions. Their performance within and outside the college in various academic events helps to evaluate the learning outcomes.
- Placements, self-employment, entrepreneurship status and social initiative of the students show the result of COs and POs as stated by the institution.
- Through various activities students acquire communication skills, creative skills, leadership skills, spirit of teamwork, willingness to take responsibility and accountability. The outcome of the entire exercise is that the evaluation method does not become a hurdle while evaluating students' attainment of COs and POs of specific course.
- The Head of each department holds meetings of the faculty members to discuss result analysis and students' feedback.

- Students' progression to higher education is noticed.
- After completion of degree students attend various on campus and off campus interviews and their successful placement shows attainment of COs and POs.

Research Activities:

There are 07 research guides recognized by Kavayitri Bahinabai Chaudhari North Maharashtra University, Jalgaon. Under their guidance 08 students carry their research work for Ph.D. degree.07

students have been awarded Ph.D. degree by Kavayitri Bahinabai Chaudhari North Maharashtra University in last five years. During last five years the faculty attended 322 Webinars, Seminars, Conferences, Workshops and presented 81papers in National/International Webinars, Seminars, Conferences, Workshops and published 72 research papers in reputed journals. The college organized 33 Webinars/Seminars/Conferences/Workshops/Training Program to share knowledge. 12Teachers participated in Faculty Development Programmes to perceive and disseminate adequate knowledge for enhancing innovation in teaching learning process. Almost all faculty members present and publish their research work and disseminate their subject knowledge in various seminars and conferences. To upgrade the subject knowledge, third year students are assigned small projects based on curricula. Some research students take advantage of research laboratories from other institutions.

IQAC:

The institution has an active and functional Internal Quality Assurance Cell comprising the representatives of all stakeholders. It conducts regular meetings to plan and review various programs and innovative activities essential to develop a conductive eco-system for teaching learning process based on the vision and mission of the institution.

Skill Development:

To nurture budding entrepreneur's value-based courses such as Certificate Course in Women Entrepreneurship, Dress Making, Basic Beauty Parlor, Nursery, Human Rights, GST, Certificate Course and Diploma Course in Communicative English help to initiate and transfer of knowledge.

Innovations in sustainability and green campus:

The college has Vermi Compost Plant which transfers a message of sustainability and green ecosystem to our youth. It not only aims to earn money but also to aid society by providing good quality of organic manure for sustainable agro practices. Most of the compost is utilized in campus. Some of it is sold in neighborhood community. The college has installed rainwater harvesting system and it recharges ground water. The use of renewable energy is practiced by installing 20 KV solar power grids. A botanical garden with various plants is developed for teaching-learning purpose by department of Botany.

Library as learning resources:

Library is fully automated through Integrated Library Management System (ILMS) designed by Master Software, Nagpur by cloud base support. Facilities like database backup and restore facility are available. This facilitates the quick access to the educational resources and encourages the teaching-learning process. In the library, 3 computers are available with 100 Mbps internet connectivity and power backup facilities. The library is a knowledge resource center of the college and provides adequate services to its users.

3.4 Extension Activities

3.4.1

Outcomes of Extension activities in the neighborhood community in terms of impact and sensitizing the students to social issues for their holistic development during the last five years.

Response:

The institution organizes most of the Extension Activities every year through NSS unit, Yuvati Sabha, Student Development committee etc. These activities bring the students and teachers in close contact with the neighborhood community. 4.1 Physical Facilities

4.1.1

The Institution has adequate infrastructure and other facilities for,

- teaching learning, viz., classrooms, laboratories, computing equipment etc
- ICT enabled facilities such as smart class, LMS etc.

Facilities for Cultural and sports activities, yoga centre, games (indoor and outdoor), Gymnasium, auditorium etc (Describe the adequacy of facilities in maximum of 500 words.)

Response:

The college campus area is 10282.96 sq. m. The lush green campus is maintained in good design with beautified infrastructure. The Management takes keen interest and efforts to create and enhance the physical facilities as and when required to provide quality education. The infrastructure is raised to meet the needs as & when required.

Demarcated areas for office, teaching, experimental& research work, sports, cultural activities, girls hostel, botanical garden, canteen, library, playground, parking, cycle stand are witnessed in the campus.

The institute has adequate infrastructural facilities for teaching and learning.

There are spacious 23 classrooms and 01 seminar hall well illuminated of ventilated. Out of 23 classrooms 03 are ICT classrooms and 01smart class room. There are in all 13 laboratories which are adequately equipped. Various departments use a range of models/charts for teaching and learning. Apart from this there are equipments like Trinacular Research Microscope, Autoclave ,Inoculation Chamber, Water bath, Digital camera ,Refrigerator, ,Domestic Microwave Oven, U. V. Chamber, LCD projectors, scanners, laptops etc. For the certificate courses in Beauty Parlor and Dress Making two separate rooms are made available with necessary infrastructure and equipments. In the Library, separate reading room is available for staff & students. The NRC centre is available for students in the campus. The cultural hall is well furnished for conducting various activities. Botanical garden is maintained with varieties of herbs & shrubs. Variety of different plants in the campus which are used for experimental purpose in the subject of Botany.

Some other specialized facilities are- Solar power grid, Inverter, Vermi composting unit, Xerox facility. Departmental Library. Most of the departments have independent departmental library and computer facility for students and teachers. Wheel chair and ramp facility for the divyanjan students is available.

The facilities available in the college for sports, games and cultural activities are as follows:-

• A Gymkhana with the area of 550 sq. ft. The indoor games such as chess, carrom, table tennis etc. are played here. Playgroundwith an area of 1400 sq. m. And a basketball court on the

ground. Students play games like basketball, volley ball, football, Cricket, Kabaddi etc. on this ground.

- The playground of the sister concern school with an area of 660sq.m. is utilized for sports when required.
- The well equipped gymnasium having an area of 85.28 sq. m. is open for students and women in the community.
- The cultural hall with an area of 334.45sq.m. is used for extracurricular activities.
- The stage constructed in front of the academic building has an area of 115.20 sq. m. and is used for the annual gathering& cultural activities.

4.2 Library as a Learning Resource

4.2.1

Library is automated with digital facilities using Integrated Library Management System (ILMS), adequate subscriptions to e-resources and journals are made. The library is optimally used by the faculty and students

Response:

The Library of the college is housed in separate building of 3595 sq.ft. There are two reading rooms; one for students and other for faculty members.

Integrated Library Management System (ILMS)

The library of the College is well-stocked and fully automated through Integrated Library Management System (ILMS) designed by Master Software, Nagpur since 2020-21 by cloud base support. Earlier LMS was used in the library. In 2021 library purchased updated software i.e. LIBMAN- Library Management System. Library is using ILMS (Integrated Library Management Software) system having Web based software for Library automation and e-facilities are available to access e-resources.

The version of the software is LIB-MAN 2.1.0.Library comprises modules such as Masters, Book Management, Barcode Facility, Book Accession, Membership, Circulation, OPAC, Catalogues, and Administration etc. The cloud based software is having additional features such as members' photographs, book reservation facility, the status of a book such as withdrawn / write-off /damaged/lost and paid. Facilities like database, backup, restore are available. This facilitates the quick access to the educational resources and strengthens the teaching-learning process.

Library has OPAC facility available for books searching. There are computers with 100 Mbps internet connectivity with power backup facilities. One node is open for the students to use OPAC facilities. Another node is for the administrative purpose.

Library is attached with internet connectivity and one Scanner- printer machine to facilitate the multicopying or printing of study and other materials. QR Codes facility is available for easy access. The Library is under CCTV surveillance and it is installed in Stack Room.

Library has a collection of 16625 Books,8 journals,9 Magazines, 2345 bound volumes of periodicals & journals, 04 newspapers and Question Bank. The Library has N-LIST facility which provides more than 3 Lakhs e-Books, and 6000 e-Journals.

Per Day uses of Library:

Percentage per day usage of library by teachers and students is varying. Sometimes it's reached up 15 to 20 visitors per day. On an average 30-35 books have been issued per day. The library can accommodate 75students in reading room, at a time.

Journals and Periodicals:

Library purchases various types of periodicals and journals. All the journals and periodicals are displayed in the separate journal racks.

The library is a knowledge resource center of the college and provides adequate services to its user. Library celebrates *Vachan Prerana divas*, *Ranganathan Jayanti* and conducts Book Review Competitions every year to motivate the habit of reading among students.

ICT enabled education help students acquiring the knowledge which play vital role in providing education very effectively. Network Resource Centre with broad band connectivity in the college help students to access information and study material for presentation of papers, and designing projects.

College regularly updates the IT facilitate to improve its efficiency. College has established procedure for updating it. Lab technicians periodically check the requirements & update it accordingly. Institute hires a private technician from outside agency to update if it is necessary as and when required.

There are 86 Computers with internet connectivity out of which 73 computers are available for student's usage. Along with this 12 printers, 03 Scanners, 01 Xerox machine, 02 all-in-one machines (Printer, scanner, and Xerox), and 1 barcode machine are available. The administrative office and library are automated by using Master soft Software for Online admission and Library Management. The Language lab is augmented with software and audio-video material to develop communication skills among students. The ICT Class rooms and Smart Classroom are equipped with LCD Projectors for effective teaching-learning. The computers in the computer science, Commerce and Management and Language Laboratories have Internet with High-Speed LAN. Since 2019-20college has upgraded to100 MBPS optic fibre broadband internet connection. Free (Open Source) software's are used for teaching learning purposes in some departments.

Library is fully automated through Integrated Library Management System (ILMS) designed by Master Soft, Nagpur since 2020-21 by cloud base support. In the library, 3 computers are available with 100 Mbps internet connectivity and power backup facilities. One node is open for the students to use OPAC facilities. Another node is for the administrative facility in the library. Library provides access to e-journals and e-books through N-List program INFLIBNET.

Financial Administration, Examination work through software

(ADES) helps institute and students to access documents and reduce paperwork, time and energy.

The institution has 4 well equipped computer laboratories to effectively conduct the undergraduate & postgraduate courses in Computer Sciences. College has UPS backup facility in some departments. The College website is regularly updated.

The college provides sufficient bandwidth for internet connection. Users within the institute can simultaneously access online resources, websites, streaming services, and other internet-based applications. The institute is connected to a trustworthy BSNL plan that offers high-speed internet connection. Computer Science Lab and administrative building have Wi-Fi network.

The Institution subscribes to a genuine 50Microsoft License. The College periodically updates its Antivirus software.

6.3 Faculty Empowerment Strategies

Every year the College prepares each department's workload for submission to the Joint Director, Higher Education Division, Jalgaon.

Year-wise appraisal of the non-teaching staff is taken in the standard format provided by Government of Maharashtra which is reviewed by the Office Superintendent and then the Principal. The authorities convey their observations in oral form to the concern staff and attempts are made to improve the performance.

6.4 Financial Management and Resource Mobilization

6.4.1

Institution has strategies for mobilization and optimal utilization of resources and funds from various sources (government/ nongovernment organizations) and it conducts financial audits regularly (internal and external)

Response:

The College receives grant-in-aid from the Maharashtra Government and a variety of special funding from bodies like UGC and KBCNMU, Jalgaon. Grants received for Minor Research Projects from funding agency are used for the same specific purpose. In the year 2019-20 the institute received fund of Rs. 10,47,281/- for installation of Solar Gird Power System (20KV) from non-government funding agencies such as Mahaveer Engineering, Jalgaon and Tapi Prestressed Products Ltd, Bhusawal.

In the year 2019-20 the Sanstha received CSR fund of Rs. 10,000,00/- for Smart Classroom set up and installation of CCMSERP software from ISC Project Private Limited, Pune.

The other regular sources of income are students' fees of add-on-courses, self-finance courses, grantable courses and general breakage fees. Scholarships and free ships from government are periodically received and the share of tuition fees and other fees are deposited in the Bank Account. Annual budget of the institute reflects the establishment expenditure including salary and non-salary components. The institute has well defined procedures for allocation of funds to various segments. The utilization of additionally generated funds by the institution from above sources is done for students and staff welfare activities, infrastructural maintenance, organization of programmes, payment of non-grant teaching and non-teaching staff etc.

The institute conducts internal and external audits periodically. Transparency is strictly maintained in both internal and external audits.

Internal Audit:-

Shri Saraswati Vidya Prasarak Mandal, Bhusawal has appointed as an internal auditor. He examines the details of fees deposited, expenditure, vouchers etc. and on this basis, he provides income and expenditure statement and balance sheet of the year. Audited financial statements and its reports are obtained at the end of the year. They are discussed and approved in the Annual General Meeting in the Month of September.

External Audit:-

- Audit of the funds received from Joint Director is done by Joint Director Officer, Jalgaon.
- B.C. Scholarship Audit is done by Social Welfare Department.
- NSS and Students Welfare Scheme and it is undertaken by the University.
- Examination, Earn while Learn Scheme and it is undertaken by the University.

If there is objection to the way funds are utilized, such accounts are withheld from final installment. Similarly, if the funds are not utilized as per the rules of funding agencies the funds have to be refunded with interest specified by agencies.

During Last Five Years there is no major objection. Queries are cleared time to time through interface meetings.

7.1.1

Response:

The College is specially run for women. The college is very sensitive to gender related issues and has taken a lot of care for safety of the girl students and staff in the campus. The suggested guidelines for the safety for women at the workplace are broadly categorized under following heads:

Safety and Security: The security guard (Peon) at the main entrance of our college always keeps watch on the students and visitors. Measures like Entry with I-card, Night watchman, Single door entry and exit in library, Visitors register is adopted. Campus is protected by wall compound; Hostel building is in the campus, Entry in IN-OUT register for hostel students is mandatory Students are not allowed to cover the face by scarf in the campus. Students are not allowed to purchase eatables or snacks from outside. Separate support staff is assigned in Parking, Ramps, wheelchair; small stools are provided for physically challenged students, Fire Extinguisher, First aid boxes are available in Laboratories. Solar street light is installed in the campus, Police protection is sought during annual gathering.

CCTV Camera: CCTV cameras are installed at various strategic points or location in the campus to ensure the safety and security. It helps us to keep our premises free from external nuisance. It also makes the college environment safe for students. Group insurance of students.

Self-Defense Program: Every year the college conducts self-defense training camp such as Karate (*Swayamsidhha*) for students through Yuvati Sabha which helps girls to improve their self-confidence.

Anti-ragging and Sexual Harassment Committee/ICC: The college has an Anti-ragging and active Sexual Committee or ICC which conducts orientation program for the girl students at the beginning of every academic year. This creates a hassle-free ambience for the female students and helps them to focus on their academics.

Counseling: Our college faculties provide both, group and individual counseling to help students to avoid addictions, personal concerns, career planning, career development, job opportunities and gender specific issues etc. The parent meet is conducted every year. Mentor-Mentee scheme is active through which personal counseling is imparted.

Yuvati Sabha and Health center: The College has a separate and dedicated cell of girl students called Yuvati Sabha which is headed by female teachers and all admitted girl students are members. This cell provides exclusive platform to girl students for their personality development. The cell conducts various activities which includes workshops, seminars, expert lectures, competitions etc. It also conducts health

related activities. It actively encourages the participation of students from rural and disadvantaged backgrounds by organizing cultural programs through the National Service Scheme.

Hostel for Girls: The college has facility of girls' hostel which provides safe and secure residence. About 80 students can be accommodated in the hostel. Appointment of Matron for hostel students is done. Faculty in the capacity of hostel in-charge is deputed.

Common Room: The common room for the girl students is available to maintain their privacy and personal needs. It is equipped with basic amenities and facilities.

7.2.1

Response:

Best practice I:

1. Title of the Practice: Inculcation of Ethical Values among students

2. Objectives of the practice:

i) To create an environment of transparency and introspection.

ii) To develop self-respect and self-discipline.

iii) To inculcate spiritual and ethical values among students during their regular study.

iv) To develop holistic approach among students.

3. The Context: Education system aims at inculcating human and spiritual values ultimately. Therefore, the institution insists on arranging programmes to motivate students and generate conducive atmosphere to inculcate moral values in the campus. Day begins with Morning Prayer to inculcate ethical values among students.

4. The Practice: Lectures are delivered by external experts and internal resource persons on topics like integrity, responsibility, empathy, righteousness, piety, courage and Indian ethos among the students. All the activities mentioned above are conducted by various committees like Art circle, Ceremony, Student Welfare, Career Counseling, Science Association, Wangmay Mandal, Environmental Awareness, Yuvati Sabha, Yuvarang, and NSS. Ethical values are also introduced through various add-on courses like Certificate Course in Human Rights Education and Women Entrepreneurship.

5. Evidence of Success: Our institution actively organizes various programs. A gradual shift is observed in the attitude and behaviour of students in terms of introspection, differentiation between right and wrong. Students seem to be now aware of the condition of the downtrodden. They have become compassionate, prudent and supportive to the deprived groups of society. Our students also participated in various social programmes like Pulse Polio Abhiyan, Road Safety Abhiyan, Swachh Bharat Abhiyan, Yuvarang, YuvatiSabha, KarmaveerBhaurao Patil Earn while Learn Scheme.etc.

6. Problems Encountered and Resources Required: The programs conducted by the Institution are useful for the students. Due to semester system the time for conducting program is not sufficient. Due to COVID-19 pandemic it was impossible to conduct offline classes. The eminent personalities are difficult to be invited to deliver lectures. The programmes require more funds. The programmesorganized by various committees to impart ethical and spiritual values among students. It requires more time and efforts and sometimes affects regular academic activities.

Best Practice II:

1. Title of the Practice: Book Review Competition by Library.

2. Objectives of the Practice: To make students read selective literature at their own pace. To inculcate reading habit among students. To increase thinking and literary interest among students. To increase subject knowledge of the students. To create social awareness among the students to improve life skills.

3. The context: The Principal and members of the Library Committee came out with an excellent stimulus to activate Reading-Writing skills among students.

4. The Practice: In modern era, students don't spare time for reading books as they are interested more in watching television and Internet. To develop good read habit among students, the members of the library committee and language experts in our institution provide freedom to students to select a book of their choice which includes mainly life sketches of eminent personalities, autobiographies and literature etc. Students enroll in the book review competition at their own will. Systematic and planned book issuing is monitored. Perceptions of individual readers of each book are submitted in the library, which are examined by the expert committee. The winners are appreciated and given prizes in Prize Distribution Ceremony. All this helps to nurture and enhance reading as well as summarizing abilities among students.

5. CONCLUSION

Additional Information :

The institution functions with the vision "**Enrichment of Women through Quality Higher Education for Better Society and Stronger Nation**" for four decades in Bhusawal. It is affiliated to KBC North Maharashtra University, Jalgaon. It has completed three cycles of accreditation and is due to be accredited for fourth cycle. It offers 12 UG and 05 PG programmes in the faculties of Arts, Commerce & Management and Science. Along with regular UG and PG programmes, it also offers add-on/value added courses.

Admissions to all programmes are given as per norms and rules by North Maharashtra University and Government of Maharashtra. About 70-80% students belong to moffusil area. Teaching learning methods and student centric teachers are motivated to use modern teaching aids. Experiential learning is imparted by conducting co-curricular, extracurricular and extension activities. At present 09 full time teachers are having Ph.D. and 03with M.Phil. as highest qualification. Semester system of examinations is conducted by the University. Around 30-40% students pursue their higher studies.

Research promotion committee encourages the faculty and students to participate in seminars and conferences. INFLIBNET N-List facility and Network Resource Centre are available for students and faculty. The institution has collaborations and MoUs with other academic and professional bodies. Necessary support services and facilities are given to students and teachers. Participation to student's representatives is given in academic and administrative committees. Alumni meets are arranged every year.

College Executive Committee, College Development Committee and IQAC contribute to the development of students and teachers. The institution offers different welfare schemes for students, teachers and non teaching staff. Internal and external audits ensure transparent financial management of the college.

Concluding Remarks :

The college insists to create awareness about environment and social responsibilities among students by conducting various practices. Inculcation of ethical values, book review competitions, good examination results, enriched library, well developed gymnasium and clean and well disciplined campus are some of the notable features.
